RECOMMENDATION

THAT City Council give 1st, 2nd and 3rd reading to Bylaw No. 5597, <u>Closure and Sale of Streets and Lanes.</u>

TOPIC AND PURPOSE

The purpose of the proposed Bylaw is to to close streets and lanes within the South East Industrial area to facilitate the consolidation and sale of City land to Carpere Canada, in accordance with the Offer to Purchase between the City of Moose Jaw and Carpere Canada Industrial Park Corp, executed on May 28, 2019.

BACKGROUND

City Council, at the regular meeting held on August 26, 2019, approved the minutes of the August 20, 2019 Municipal Planning Commission meeting at which the following motion was passed:

"THAT the Municipal Planning Commission recommend to City Council that the subdivision and consolidation plans in the NW & SW 27-16-26 W2M, NE28-16-26-W2M, and SW 34-16-26-W2M, be approved subject to the review process being completed and;

THAT City Administration be directed to proceed with the necessary street and lane closure bylaws"

Pursuant to *The Cities Act*, a Notice of Intention to Close and Sell Streets and Lanes was advertised in the August 28 and September 9, 2019 issues of the <u>Moose Jaw Express</u>. The Bylaw and notice were also published on the City's webpage and sent directly to all property owners within 90 meters of the proposed closures. No comments have been received to date. Additional comments may be received by the City until 10:00 am on September 9, 2019.
