RECOMMENDATION

THAT Liam Vargo be appointed as a youth-at-large representative to the Youth Advisory Committee for a term of office to commence immediately and to conclude June 30, 2020.

TOPIC AND PURPOSE

The purpose of this report is to present City Council with the application from a student at Peacock Collegiate who has expressed interest in appointment to the City's Youth Advisory Committee.

BACKGROUND

At the September 9, 2019 City Council meeting, appointments were made to the Youth Advisory Committee. On October 10, 2019 an application for appointment to the Youth Advisory Committee was received from a student at Peacock Collegiate.

DISCUSSION

Members of the Youth Advisory Committee are appointed by City Council on an annual basis for a term of office of one (1) calendar school year. Meeting schedule dates and times are determined at the first meeting of the year. Participation in the Youth Advisory Committee is on a voluntary basis.

Ecole Ducharme School Saskatchewan Polytechnic

• Up to four (4) youth-at-large representatives (age 18 to 25 years and cannot be students from schools currently represented on the Committee.)

As there is currently one youth-at-large representative from Peacock Collegiate on the Youth Advisory Committee and another application has been received, it would be in order to appoint the second applicant to the Youth Advisory Committee.
