- Holiday schedule for skating, Yara Centre turf and the Sportsplex pool will be released for the holiday season.
- The Department held a meeting with all Community Associations to review what the associations are doing, their purpose, and what they want to accomplish. A new Community Initiatives Program discussion will focus on 2021 direct support funding model.
