#### RECOMMENDATION

THAT Councillor Crystal Froese be appointed as the City Council representative for the Cultural Diversity Advisory Committee for a term to commence immediately and to conclude November 9, 2020, or until a successor is appointed.

### TOPIC AND PURPOSE

The purpose of this report is to appoint one elected official to City of Moose Jaw's Cultural Diversity Advisory Committee for a term to commence immediately and to conclude November 9, 2020, or until a successor is appointed.

### BACKGROUND

On December 16, 2019, City Council adopted motions to appoint Council representatives to the City's Boards, Committees and Commissions. At that time, no member of City Council had placed their name forward for appointment as the City Council representative to the Cultural Diversity Advisory Committee.

On January 3, 2020, the City Clerk/Solicitor's Department received an email from Councillor Froese advising that she was placing her name forward for appointment to the Cultural Diversity Advisory Committee.

## DISCUSSION

As there is currently a vacancy for a City Council representative on the Cultural Diversity Advisory Committee and Councillor Froese has placed her name forward, appointment of Councillor Froese is recommended.
