RECOMMENDATION

THAT City Council give 1st, 2nd and 3rd reading to Bylaw No. 5615, Sewer and Water Utility Bylaw Amendment, 2020(1).

TOPIC AND PURPOSE

The purpose of the proposed Bylaw is to make amendments to Schedule "A" of the City of Moose Jaw's Bylaw No. 5152, Sewer and Water Utility Bylaw.

BACKGROUND

At the Special City Council Meeting on December 11, 2019, Council passed the following resolution respecting the above captioned matter:

"Resolution #: 2019-12-11-575

THAT Waterworks Utility rates be increased 6% effective February 1, 2020.

Resolution #: 2019-12-11-576

THAT Sanitary Sewer Utility rates be increased 5% effective February 1, 2020."

The purpose of the proposed Bylaw is to amend Schedule "A" of Bylaw No. 5152, Sewer and Water Utility Bylaw to reflect changes in the Waterworks Utility Rate Schedule and the Sanitary Sewer Utility Rate Schedule adopted at the Special City Council meeting held December 11, 2019.

If City Council is inclined to support the Bylaw and clause-by-clause debate is not required, the following motion would be in order, while in Committee of the Whole (Bylaws):

"THAT clause-by-clause consideration of the Bylaw be and is hereby dispensed with and that the said Bylaw be approved in its entirety."
