4.1 2019 Moose Jaw Heritage Awards

Consideration was given to nominations for the 2019 Moose Jaw Heritage Awards.

4.2 Website Heritage Mapping

Eric Bjorge, Assistant City Planner, presented a power point demonstrating the City's new website's heritage information and photos including municipal heritage sites, designated heritage properties, properties of heritage interest along with the mapping feature. The City's new website is currently under construction and is scheduled for completion by the end of January 2020.

4.3 Heritage Reserve Account

Eric Bjorge, Assistant City Planner, advised that funds in the amount of approximately \$17,000 to \$18,000 are in the Heritage Reserve account. Mr. Bjorge informed the Committee that there is also a Downtown Parking Reserve account that earns roughly \$40,000 in interest yearly. Mr. Bjorge proposed the creation of a combined Heritage and Downtown Reserve account with funds in the proposed account being used for projects with heritage components in the downtown area (ie. arches on Langdon Crescent, coach house behind 5th Avenue Jewellery, City Hall bell tower clock, façade improvement grant, etc.) Feedback was received from the Committee. Administration plans to take a report forward to City Council regarding the matter.

Re: Business Arising from Minutes

5.1 Downtown Façade Improvement Grant Application - 510 Main Street North

Considered was the grant application from the Moose Jaw Non-Profit Housing Corporation for proposed façade improvements at 510 Main Street North. If the program continues, the Committee noted that potential changes to the criteria in the grant application may be required. Discussion ensued with the Committee deciding that the matter should be referred to the City Manager for review.
