## **RECOMMENDATION**

THAT City Council give 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> reading to Bylaw No. 5602, Zoning Amendment Bylaw, 2020 (1).

## **TOPIC AND PURPOSE**

The purpose of the proposed Bylaw is to remove all references to the Municipal Planning Commission from the Zoning Bylaw.

## **BACKGROUND**

At the regular meeting of City Council on November 12, 2019, the following motion from the October 28, 2019 Executive Committee meeting was ratified:

*"THAT the Municipal Planning Commission (MPC) be disbanded with reports from the Department of Planning and Development Services going directly to City Council for review and approval."*

Disbanding the Municipal Planning Commission requires bylaw amendments to the Official Community Plan (OCP) and Zoning Bylaw, to remove the Municipal Planning Commission from the review process of planning matters.

In accordance with *The Planning and Development Act, 2007*, and City practice, the Bylaw amendment has been advertised for two (2) consecutive weeks in the Moose Jaw Express and on the City website. No written submissions have been received to date.

If City Council is inclined to support the Bylaw and clause-by-clause debate is not required, the following motion would be in order, while in Committee of the Whole (Bylaws):

*"THAT clause-by-clause consideration of the Bylaw be and is hereby dispensed with and that the said Bylaw be approved in its entirety."*
