## RECOMMENDATION

THAT the City of Moose Jaw Financial report for the January 1, 2019 to December 31, 2019 period be received and filed.

#### TOPIC AND PURPOSE

The purpose of this communication is to provide City Council with information respecting the 4<sup>th</sup> Quarter of 2019 including financial condition indicators, summarized report on Capital Expenditures and statistical information for the period January 1, 2019 to December 31, 2019.

## BACKGROUND

The City's summarized financial information is presented to City Council on a quarterly basis.

## DISCUSSION

#### **Financial Condition Indicators:**

The Financial Condition Indicators provide an effective method to review the City's key financial indicators.

Those presented are an initial group of indicators and will be refined over time to meet the City's needs as they change in the future.

## Revenue & Expenditure Summary:

The 4<sup>th</sup> Quarter Revenue and Expenditure Report has not been provided as year-end work is underway and the information if provided at this point would not be indicative of final year-end results.

As Council is aware, the City has embarked on a project to shorten the length of time for year-end information to be presented to City Council.

City Administration plans to have preliminary year-end information by February 28, 2020 and complete year-end information by April 3, 2020. If Council desires the preliminary year-end, results could be shared with Council at a March Council meeting or if more accurate results are wanted, in April. The final audited statements are scheduled to come to Council in May.

#### **Capital Project Status Report:**

The report provides an overview of the status of the City's capital projects.

#### Statistical Information:

This section contains information on the City's statement of property tax arrears, property taxes receivable, borrowing and tender/RFPs awarded by the Financial Services Department.

## Mosaic Place Statement:

Included with the 4<sup>th</sup> Quarter Financial Report is a summarized Mosaic Place Financial Statement which includes a balance sheet and income statement produced by Spectra who manages the facility for the City of Moose Jaw. The report is from September 3 to October 31, 2019.
