RECOMMENDATION

THAT City Council give 1st, 2nd, and 3rd reading to Bylaw No. 5666, <u>The Moose Jaw</u> <u>Municipal Airport Authority Guarantee Bylaw Amendment, 2022 (1)</u>.

TOPIC AND PURPOSE

The purpose of the proposed Bylaw is to amend Bylaw No. 5643, <u>The Moose Jaw</u> <u>Municipal Airport Authority Guarantee Bylaw, 2021</u> to extend the line of credit to October 31, 2022.

BACKGROUND

City Council, at their April 25, 2022, meeting, adopted the following resolution:

"THAT City Administration be authorized to craft an amending bylaw to extend the line of credit to October 31, 2022, as part of Bylaw No. 5643, <u>The Moose Jaw</u> <u>Municipal Airport Authority Guarantee Bylaw, 2021</u>, being a bylaw of the City of Moose Jaw to authorize a revolving line of credit for the Moose Jaw Municipal Airport Authority."

It allows for the City of Moose Jaw to provide bridge financing to the Moose Jaw Municipal Airport Authority for the runway capital upgrades under the ICIP Program. This Bylaw required the revolving line of credit to be completely repaid by April 30, 2022, which has been completed. Some work remains to be completed in 2022 which has necessitated this request.
